Mr. Perry Constantino, 109 Dakotah Drive, states the proposed trench (170 feet x 6 feet) affects Mr. Tom Benjamin, 111 Dakotah Drive, and himself. He contacted Center Township prior to installing an eighteen (18) inch pipe several years ago. Mr. Constantino met with Township Engineer Heath on December 29, 2021 to discuss the safety concern of an open trench. Center Township is responsible for public safety. Center Township should reconsider the safest and effective solution. Pringle and Wulff visited the site today. Wulff thinks the pipe is clogged. Mr. Constantino and Mr. Benjamin agree to provide a hold harmless agreement to the Township for exploration of cause. Wulff motioned to reject all bids. Pringle seconded. Motion carried.

Pringle motioned authorizing Township Solicitor Gallagher to prepare a hold harmless agreement between Center Township, Mr. Constantino and Mr. Benjamin to access the stormwater system. Wulff seconded. Motion carried.
