Gallagher stated "Since health benefits are authorized by the Second Class Township Code, supervisors are allowed to vote on their own wages and benefits."

Latuska realizes the high cost of insurance and presented a check in the amount of \$2,500 (annual salary) payable to Center Township to offset the cost of health benefits.

1. Covington Stormwater Land Development No. 11-12-10 - 105-107 Covington

Drive - Preliminary/Final: Mr. Shawn Bobbert, 105 Covington Drive, and Mr. David George, 107 Covington Drive, presented a plan to replace current storm water retention pond with a series of inlets and pipes. Frenchak motioned to grant, based on the Planning Commission recommendation, preliminary and final approval for the Covington Stormwater Land Development No. 11-12-10. Erie seconded. Motion carried unanimously.

OLD BUSINESS: None

NEW BUSINESS:

- 1. Butler County Humane Society Agreement: Flatt motioned to sign the agreement with the Butler County Humane Society authorizing James Wagner, Dog Officer, to drop off dogs. Erie seconded. Motion carried unanimously.
- 2. Release 2011 Fire Tax: Erie motioned authorizing the release of \$90,000 from the Fire Protection Fund to Unionville Volunteer Fire Company. Frenchak seconded. Motion carried unanimously.
- 3. Generator Maintenance Service Agreement: Cummins Bridgeway submitted a semi-annual equipment service agreement for the generator located at the Maintenance Facility, 150 Henricks Road. The Road Department employees will be responsible for maintaining the generator.
- 4. Appoint Seasonal "On Call": Flatt motioned appointing Jared Smith as seasonal "on call" at \$13.50 per hour and clarify that Kenneth Blatt Jr and Thomas Hepfl were hired as seasonal "on call". Frenchak seconded. Motion carried unanimously.

PUBLIC WORKS DIRECTOR:

- 1. Truck Alternator: During the winter storm, January 2, 2012, an alternator had to be replaced on one of the trucks.
- 2. Township Vehicle Use: Lauer stated he was hire in 1998. Schenck, Latuska, and Plaisted issued a vehicle for his use. The vehicle is not used for personal use. The owner of the Spillway Bar granted permission to the Township to stockpile stone at that location.
- 3. Hatch Act Violation: Lauer received a letter from the Office of Special Counseling in regard to a possible violation to the Hatch Act. The Office of Special Counseling stated it would take no further action. He stated the Board has the responsibility to protect employees from harassment.

ENGINEER'S REPORT: None

SOLICITOR'S REPORT:

1. Transfer Property to Center Township Athletic Association: Township Solicitor prepared a deed to transfer property (ball fields) to Center Township Athletic Association. If property is no longer used by the Center Township Athletic Association, the property will revert to Center Township. In addition, the Township will retain the mineral rights, if any. Gallagher will prepare a lease termination for the annual lease payment. Frenchak motioned authorizing Flatt to sign all

necessary papers to transfer the property (ball fields) to Center Township Athletic Association. Erie seconded. Motion carried unanimously.

MISCELLANEOUS:

- 1. Frenchak stated the Planning Commission will draft a welcome letter for new businesses. Dollar General is still waiting for the transfer of property before issuance of building permit. He feels the Board should not be distracted by the community response and move forward.
- 2. Flatt stated there is no further information on the site selection for the Veterans' Administration Hospital expansion.
- 3. Erie stated the Township applied for health insurance through Pennsylvania State Association of Township Supervisors. The Township could realize a savings of \$120,000. He thanked Latuska for questioning the rising costs healthcare.

ADJOURNMENT:

The meeting adjourned to executive session to discuss engineering proposals at 7:20 p.m. The meeting reconvened at 8:05 p.m. with no action being taken.

Flatt made a motion to adjourn at 8:07 p.m. Seconded by Frenchak. Motion carried unanimously.
