Since billing for motor vehicle accidents, the department recouped \$4,700.00 which is a collection rate of fifty-five (55) percent.

Senate Resolution 6 discusses the problem of retaining volunteer firefighters especially during daylight hours. The proposed Moraine Fire District Cooperative would combine sixteen (16) municipalities creating a north and south zone. It would establish two (2) paid positions at Slippery Rock Volunteer Fire Department and two (2) paid positions at Unionville Volunteer Fire Company. The proposed wage is \$15.00 per hour. The municipalities would be required to make an annual contribution of approximately two (2) mills. Mr. Wulff requests assistance from Township Secretary/Treasurer Amendolea and Township Solicitor Gallagher concerning workers compensation and any legalities.
