1. Economic Resources Overlay District: Frenchak stated that the Planning Commission should act on the Economic Resources Overlay District Ordinance as presented. The Commission was concerned with the parking requirement as stated in Section 20-1406.II H which reads "All required parking shall be in the rear of the structures, where feasible, as per Section 20-1701 E 1 and the restriction of operating hours for day care centers as stated in Section 20-1407-II D 4 which reads, "The hours of operation shall be limited to the hours between 5:30 a.m. and 8:00 p.m.". Scheibel motioned recommending, elimination of Section 14-1406 II H and Section 20-1407.II D 4, approval of the Economic Resources Overlay District ordinance. Ashbaugh seconded. Motion carried.
