## **PUBLIC TO BE HEARD:**

- A. Ms. Brenda Sebring: Ms. Sebring represents Weaver Homes. She passed out handouts for Comprehensive Plan, Butler Area Sewer Authority letter to serve property with contingencies, Trip Generation report and Pennsylvania American Water Company letter to serve property. Ms. Sebring requests the Township reschedule a hearing.

**ZONING REPORT:** January 2020: Construction costs were \$7,000.00 fees collected were \$820.00.

## **SUBDIVISION & LAND DEVELOPMENTS:**

- A. Martin Sales Land Development No. 2020-01-01, Preliminary & Final, Expires: 04/21/2020: Mr. Joe Gray presented. Mr. David Martin proposes to remove the lot line between 1633 North Main Street Extension (Center Township Map 060-S3-A4) and 1735 North Main Street Extension (Center Township Map 060-S3-S4) and construct a 4,800 SF storage building that will accommodate current storage needs associated with the existing Martin Sales and Service business. Stormwater will be stored underground. Butler County Planning Commission comment, per letter dated January 14, 2020, was " A revised property deed also needs to be recorded when a parcel is altered so that the change can be properly accounted for in the Butler County Mapping and Assessment offices." Township Engineer Heath comments are, as follows (Mr. Joe Gray's comments are italicized):
  - 1. Approval letter dated 1/14/2020 has been received from Butler County Planning Commission regarding the Lot Line Revision Plan.
  - 2. PA One Call serial number to be included on the plans. (noted on plan)
  - 3. Screening needs to be added to the plans along the north-east boundary of the lot that abuts residential zoning, per section 14-905. (added to the plan)
  - 4. Appropriate signature and recording blocks to be included on the final Land Development and Lot Line Revision plans. (added to plan)

The Planning Commission, based on Township Engineer Heath's recommendation, recommended approval of the lot line revision between 1733 North Main Street (Center Township Map 060-S3-A3) and 1735 North Main Street Extension (Center Township Map

Building Code Official/Zoning Officer Gauselmann questioned if the existing stormwater retention, fire hydrant, screening between commercial properties were annotated on the current plan. Latuska stated the Township should follow the ordinances. Mr. Gray asked for a modification from Chapter 20, Article 20, Section 20-2001, Paragraph E, Subparagraph 1. Flatt motioned granting a modification from Chapter 20, Article 20, Section 20-2001, Paragraph E, Subparagraph 1. Wulff seconded. Motion carried.

Flatt motioned approving (1) the lot line revision and (2) preliminary and final approval, contingent of parking requirements shown on the plan and provide a modification letter for any other zoning regulations, of the Martin Sales Land Development No. 2020-01-01. Latuska seconded. Motion carried.

- C. Adopt Curative Amendment Alternative Energy Resolution No. 2020-02-09: The Board held a special meeting on Thursday, January 16, 2020 to act on a curative amendment for solar farms. Flatt motioned adopting the Curative Amendment Alternative Energy Resolution No. 2020-02-09. Latuska seconded. Motion carried.
- D. Application for Public Fire Hydrant: Pennsylvania American Water Company is replacing water line along North Drive. They asked if the Township would like to place any fire hydrants on the new line. The Unionville Volunteer Fire Company recommends placing a hydrant at the intersection of South Drive (T-302) and Middle Drive (T-304) and a hydrant at or near 215 South Drive. Smallwood motioned authorizing the placement of a hydrant at the intersection of South Drive (T-302) and Middle Drive (T-304) and a hydrant in the vicinity of 215 South Drive. Latuska seconded. Motion carried.
- E. Kern Ag Security Request: Mr. Kurt Kern submitted a application to add 89.854 acres (m/l) to the Agricultural Security Area on January 23, 2020. The Board accepts the application and will let the one hundred eighty (180) days elapse.
- F. Comprehensive Plan: The Board authorized Tracey Frampton, EADS Group, to continue with the comprehensive plan which was started by Mr. Richard Grossman. EADS Group established a rate of \$24,905.00 to be completed within six (6) months. On January 27, 2020, Sloan authorized Tracey Frampton to proceed. Sloan motioned ratifying the approval of Mr. Tracey Frampton, EADS Group, to complete the comprehensive plan for \$24,905.00 to be completed within six (6) months. Flatt seconded. Motion carried.
- G. Grant Writing Training 02/24 25/2020 Butler \$425: Butler County is conducting a two (2) day class for grant writing at the Butler County Vocational Technical School on February 24, 2020 and February 25, 2020 at a fee of 425.00 per attendee. - H. The Board will need to appoint an individual to completed Mr. Heltsley's term. If the Board desires, they may appoint an individual to complete Mr. King's term. Flatt motioned (1) removing Mr. Raymond Heltsley and Mr. Jared King as elected auditors due to (1) not responding to methods of communication, (2) failure for not attending scheduled meeting on Tuesday, January 7, 2020 and (3) failed to complete an Oath of Office.
