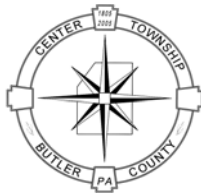

CALL TO ORDER:

Chairman Edward Latuska called the Sheetz Liquor License Transfer Hearing, of the Center Township Board of Supervisors, to order at 6:05 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

ROLL CALL:

In addition to Chairman Latuska, present were Vice Chairman Alan Smallwood; Supervisors Ronald Flatt, Kenneth Frenchak and Philip Wulff; Court Recorder Cheryl Morris; and Township Secretary/Treasurer Anthony Amendolea.

PURPOSE: The purpose of this public hearing was to obtain comment on a request by Sheetz Inc to engage in the intermunicipal transfer of a liquor license to 1518 North Main Street Extension for the purpose of selling beer for on premises consumption and to go and wine to go.

The notice of the public hearing was published in the Butler Eagle editions of Sunday, March 26, 2017 and Sunday, April 2, 2017. Property was posted on Friday, March 31, 2017.

APPLICANT COMMENTS: Mr. Mark Kozar, Flaherty and O'Hara, stated Sheetz Inc would like to sell beer for on premises consumption and to go. Wine would be sold to go. Sheetz Inc has an agreement to purchase a liquor license (R-15665) from Andora Cranberry LLC, 300 Adams Ridge Shoppes, Route 228, Adams Township, Mars PA to be used at Sheetz Inc, 1518 North Main Street Extension. Change in the Liquor Code Act 39 permit the purchase of alcohol at fueling stations. Beer sales are from 7:00 a.m. to 1:45 a.m., Monday through Saturday and begin at 9:00 a.m. on Sundays. Unopened wine sales will be until 11:00 p.m. daily. Sheetz has an one hundred (100) percent carding policy.

2. Frenchak asked about the two (2) beer limit.
3. Smallwood asked if someone purchase a six pack would they be limited to the two (2) beer limit.
