CENTER TOWNSHIP BOARD OF SUPERVISORS Regular Meeting Minutes June 13, 2012 6:30 p.m.

### CALL TO ORDER:

Chairman Ronald Flatt called the Regular Meeting, of the Center Township Board of Supervisors, to order at 6:30 p.m. The meeting was held at the Center Township Municipal Building, 419 Sunset Drive, Butler PA 16001.

### ROLL CALL:

In addition to Chairman Flatt, present were Vice Chairman Andrew Erie; Supervisors Kenneth Frenchak, Edward Latuska, and Philip Wulff; Township Solicitor Michael Gallagher; Township Engineer Ron Olsen; and Township Secretary/Treasurer Anthony Amendolea. Public Works Director Mark Lauer was absent.

### PUBLIC TO BE HEARD (3 MINUTE LIMIT):

- 1. Mr. Lloyd Eagal, 1003 Sunset Drive: Mr. Eagal owns property on Saint Andrews Drive. He requests a storm drain be placed at the corner of Lakeview Drive (T-650) and Saint Andrew Drive (Private) to control stormwater from washing out drives. Erie motioned directing Township Secretary Amendolea to notify Public Works Director Lauer of the situation and authorize Lauer, if necessary, to coordinate with Township Engineer Olsen. Latuska seconded. Motion carried unanimously.
- 2. Mr. George White, 319 Palmer Road: Mr. White asked if the Township has a "No Parking" ordinance. Township Solicitor Gallagher responded that the existing "No Parking" ordinance restricts parking on Palmer Road (T-511) and a section of State Route 8 (SR 8).
- 3. Ms. Beverly Schenck, 105 Iroquois Drive: Ms. Schenck reviewed the Board of Supervisors Special Meeting minutes held on September 17, 2002. A motion was made to permit Township employees to respond to emergency calls based on House Bill 325, which was never acted on. Flatt motioned ratifying the authorization permitting Township employees to respond to emergency calls during Center Township duty hours with compensation and annotate time sheets by a designation established by the Board of Supervisors. Frenchak seconded. Motion carried unanimously.

### MINUTES:

1. Agenda Setting Meeting Minutes - May 7, 2012: Latuska motioned approving the minutes of the Agenda Setting Meeting held on May 7,

2012. Frenchak seconded. Motion carried unanimously.

2. Regular Meeting Minutes - May 9, 2012: Latuska motioned correcting, Public Works Director section, Item 5, Page 6, Line 3, which reads "to whether" should read "whether to", the minutes of the Regular Meeting held on May 9, 2012. Erie seconded. Motion carried unanimously.

### TREASURER'S REPORT

- 1. May 2012: Frenchak motioned approving the May 2012 Treasurer's Report. Latuska seconded. Motion carried unanimously.
- Warrant List 12-05-10: Latuska motioned approving Warrant List 12-05-10. Erie seconded. Motion carried unanimously.
- 3. Warrant List 12-05-11: Latuska motioned approving Warrant List 12-05-11. Erie seconded. Motion carried unanimously.

**ZONING REPORT:** May 2012: Construction costs were \$429,675.00 fees collected were \$4,233.18.

#### NEW BUSINESS:

- 1. Municipal Building/Garage Roof Replacement: The Board desires to replace the roof on the Municipal Building and Garage located at 419 Sunset Drive. In addition, fixing the entrance doors, seal coat the parking lot and painting parking spaces are being considered. Latuska motioned authorizing receipt of quotes to replace the Municipal Building and Garage roofs. Frenchak seconded. Motion carried unanimously.
- 2. Oesterling Sandblasting Used Car Sales: Mr. Owen Oesterling, 686 Glenwood Way, attended the Planning Commission meeting held on May 23, 2012 to propose operating a used car lot [three (3) to five (5) vehicles]. The Planning Commission granted permission to operate an ancillary business and waived the Land Development process. Frenchak motioned permitting Oesterling Sandblasting to operate a used car lot [three (3) to five (5) vehicles] as an ancillary business and waive the Land Development process. Erie seconded. Motion carried unanimously.
- 3. Chambers Small Flow Facility Maintenance Agreement: Mr. Larry Chambers, 2320 William Flynn Highway, is required to repair current on lot sewage system. He is required to construct a small flow treatment facility. Mr. Chambers must have an installation and maintenance agreement between Center Township and him for Department of Environment Protection approval. Erie motioned approving the Chambers Small Flow Facility Maintenance Agreement and authorizing Chairman Flatt and Township Secretary/Treasurer Amendolea to signed necessary forms for Department of Environmental Protection approval. Latuska seconded. Motion carried unanimously.
- 4. Reimbursement of Non-Covered Medical Services: Current insurance policy does not pay all medical expenses. Erie submitted a request to be reimbursed \$477.02 for non-covered expenses. With the change in

insurance policies, the Township has realized a savings of \$59,051.16 through May 2012. Frenchak motioned authorizing the reimbursement of non-covered medical services. Flatt seconded. Erie abstained. Motion carried.

- 5. Storm Water Training June 19, 2012 1:00 PM \$0: Butler County Planning Commission will hold "Storm Water Training" on June 19, 2012 at 1:00 p.m. at no cost. There was no interest to attend.
- 6. Butler County Soccer Association Traffic: Mr. George White, 319 Palmer Road, is concerned with the Butler County Soccer Association members blocking Palmer Road (T-511) before the gate is opened. Building Code Official/Zoning Officer Round requests an order, drafted by Township Solicitor Gallagher, to abate a public nuisance by having the gate open at all times from May 1 through October 1 of each year. Flatt requests Township Solicitor Gallagher present, in writing, options the Township has to enforce "No Parking" ordinance. Since Butler County Soccer Association directors change, Frenchak will contact the current directors to rectify the situation. Mr. White suggested that any decisions be in writing for future directors.

Flatt motioned authorizing Public Works Director to attend the Annual Pipeline Safety Training on July 10, 2012 with no cost to the Township. Erie seconded. Motion carried unanimously.

### ENGINEER'S REPORT:

1. East Hilltop Drive Stormwater: Township Engineer Olsen and Flatt met on June 8, 2012 at the site to discuss options of correcting the stormwater runoff. Olsen recommends placing two (2) inlets on the west side of East Hilltop Drive and cut the road to place pipe across road to control water to a manhole at end of street. Then install pipe to run water to woods and stream. Latuska motioned authorizing Chairman Flatt to meet with Olsen, Lauer, Gallagher, and property owners to discuss the project and any easements which will be required. Erie seconded. ### SOLICITOR'S REPORT:

1. Schenck's Right to Know Appeal: Township Solicitor Gallagher stated Ms. Schenck submitted a Right to Know request to the Unionville Volunteer Fire Company for duty sheets for Lauer and Brewster and a membership list. She was provided the duty sheets but was denied the membership list. Ms. Schenck appealed to the Office of Open Records which upheld her request. Latuska motioned ratifying all actions, prior and future, that Chairman Flatt and Township Solicitor Gallagher must take to defend against Ms. Schenck's Right to Know appeal. Frenchak seconded. Motion carried unanimously.

Flatt motioned ratifying the authorization for Township Solicitor Gallagher to prepare a response to Common Pleas Court to appeal Ms. Schenck's appeal. Latuska seconded. Motion carried unanimously.

Erie felt the Board and Ms. Schenck should settle this matter. By appealing the Office of Open Records decision, the Township is spending more monies to defend the fire department.

- 2. Iron City Uniform Rental Contract: The Township received a letter from Iron City Uniform Rental requesting payment of \$29,096.60 for early termination liquidated damages. Pennsylvania law declares that no legislative body or municipal board can take action which will bind its successors. Erie motioned, based on Township Solicitor Gallagher's recommendation, voiding the Iron City Uniform Rental Contract. Latuska seconded. Motion carried unanimously.
- 3. Oliver's Appeal: Mr. Jerome Oliver appeal to the Pennsylvania Supreme Court denied Mr. Jerome Oliver's Petition for Allowance of Appeal. He has thirty (30) days to request reconsideration in the matter.
