Center Township Board of Supervisors Special Meeting - Dakotah Drive Stormwater August 23, 2021

6:00 p.m.

CALL TO ORDER:

Chairman Ronald Flatt called the Special Meeting – Dakotah Drive Stormwater, of the Center Township Board of Supervisors, to order at 6:00 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

ROLL CALL:

In addition to Chairman Flatt, present were Vice Chairman Philip Wulff; Supervisors Edward Latuska, Robert Sloan and Alan Smallwood; and Township Secretary/Treasurer Anthony Amendolea.

PURPOSE: The purpose of the meeting is to assess possible stormwater damage on Dakotah Drive.

PROPERTY OWNER COMMENTS: Mr. Thomas Benjamin purchased property at 111 Dakotah Drive (Center Township Map 060-S19-A67). He states he wants to break ground in October to construct a single family dwelling.

PUBLIC COMMENTS: Mr. William Bittner, 140 Iroquois Drive, developer of Timberidge, stated that the runoff from Dakotah Drive was not a problem until the torrential rains the past couple of years. The water flows from Dakotah Drive under Seminole Trail into a retention pond on his property. He states the Board should consider slowing the water flow down to protect the retention pond.

BOARD OF SUPERVISORS COMMENTS:

- A. Flatt stated current drainage is a twenty-seven (27) inch pipe connected to a fifteen (15) inch pipe. He stated the Township would replace the fifteen (15) inch with one hundred seventy (170) feet (m/l) of thirty (30) inch smooth bore pipe, add a catchbasin at the connection and slow water down where pipe daylights prior to Seminole Trail.
- B. Smallwood stated rip rap and concrete should be used to slow water flow and prevent further erosion.
- C. Wulff stated there is no erosion where current pipe daylights. He states that this area should be monitored.

Wulff motioned authorizing to bid for one hundred seventy (170) feet (m/l) of thirty (30) inch smooth bore pipe, catchbasin, embedded in stone and backfilled, and reseed area with the approval of two (2) supervisors to be ratified at the regularly scheduled meeting for Wednesday, October 13, 2021. Flatt seconded. Motion carried.
