A. Clearview Mall Capital Holdings Pre-Application: Mr. Ronald Olsen, Olsen Craft Associates, discussed the possibilities of Clearview Mall Capital Holdings to create separate land parcels or condominium units for the lands currently occupied by Boscov's, J.C. Penney and Rural King. Mr. Olsen met with Mr. John Nath, Professional Code Services, the units would be required to meet the Uniform Construction Code requirements.
