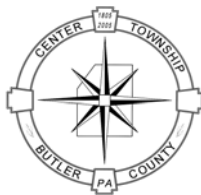

**CALL TO ORDER:**

Chairman Ronald Flatt called the 2020 Budget Workshop, of the Center Township Board of Supervisors, to order at 6:00 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

**ROLL CALL:**

In addition to Chairman Flatt, present were; Vice Chairman Phillip Wulff; Supervisors Edward Latuska, Robert Sloan and Alan Smallwood; and Township Secretary/Treasurer Anthony Amendolea.

**PUBLIC TO BE HEARD (3 Minute Limit):**

- A. Nathan Wulff, Unionville Volunteer Fire Company Fire Chief: Mr. Wulff stated since the 2.5 mills were being redistributed to the other funds, he requested the Board considered increasing the millage of the Fire Protection Fund.

**2020 BUDGET PRESENTATION:**

Township Secretary/Treasurer Amendolea presented ~~an unbalance preliminary 2020 Budget a preliminary 2020 Budget unbalanced (corrected 11/13/2019)~~ in the amount of \$65,000.00. Projected revenues, for 2020, are \$1,972,800.00 and expenditures are \$2,032,800.00. Flatt stated with the Maintenance Loan paid off, the 2.5 mills established for Debt Service will be redistributed as follows:

Capital Projects Fund	1.5 mills
Fire Protection Fund	0.2 mills
General Fund	0.8 mills

Flatt reviewed the categories of the General Fund. Township Secretary/Treasurer Amendolea will present the 2020 Proposed Budget at the next budget meeting scheduled for Tuesday, November 12, 2019.
