CALL TO ORDER:

2021 BUDGET PRESENTATION:

Township Secretary/Treasurer Amendolea presented an unbalance unbalanced (corrected 11/10/2021) preliminary 2022 Budget in the amount of \$180,100.00. Projected revenues, for 2022, are \$2,013,400.00 and expenditures are \$2,193,500.00. Flatt reviewed each of the categories in the General Fund. Flatt stated the priorities of the Supervisors are roads, fire and police service, prevention of raw sewage and reasonable building codes.

The majority of the General Fund expenditures are Engineering, Public Safety, Code Enforcement, Planning and Zoning, Public Works and General Services.

Flatt proposed to fund the paying project for 2022 by \$300,000.00 by the following ways:

- 1. Transferring \$300,000.00 in December from the General Fund reserve to the Capital Projects Fund and adjust the 2021 budget, or
- 2. Budget \$300,000.00 as a transfer to the Capital Projects Fund and the Board transfer the funds in 2022.

Smallwood stated the Board should only transfer \$150,000.00

Wulff asked if the monies could be transfer from the General Fund reserve at time of expenditure.

Latuska asked if the transfer creates any difficulties in bookkeeping.
