#### **NEW BUSINESS:**

1. Sign Ordinance: This ordinance amends the Center Township Codified Ordinances Chapter 20, Zoning, (1) Article II, Section 20-202, Specific Definitions, by adding or revising the following terms: Dynamic Display; Sign, Area; Sign, Awning; Sign, Building Mounted; Sign, Canopy; Sign, Changeable Copy Electronic; Sign, Changeable Letter; Sign, Construction; Sign, Directional; Sign, Directory; Sign, Freestanding; Sign, Ground; Sign, Internally-Illuminated; Sign, Memorial Or Tablet; Sign, Monument; Sign, Nonconforming; Sign, Off-Premises; Sign Political; Sign, Portable; Sign, Projecting;

Schaefer seconded. Motion carried unanimously*.
- 3. Mobile Home Park Chapter 20 Amendments: This ordinance amends the Center Township Codified Ordinances Chapter 20, Zoning, (1) Article II, Definitions, Section 20-202, Specific Definitions, by adding or revising the following terms: *Manufactured Housing; Mobile Home; Mobile Home Lot; Mobile Home Park; Net Acreage; Net Density; and Recreational Vehicle Park*, and (2) revises Article XIV, Conditional Uses, Section 20-1408, Conditional Use Standards and Criteria, Subsection A, Subparagraph 26, Mobile Home Park. *Lynd motioned recommending approval of the proposed mobile home park Chapter 20 amendments. Schaefer seconded. Motion carried unanimously.*
