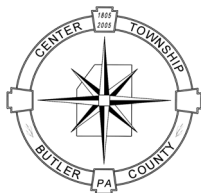

 Public Hearing - Ordinance Amendments
 November 8, 2010
 6.00 p.m.

CALL TO ORDER: Chairman Thomas Schiebel called the Public Hearing of the Center Township Board of Supervisors to order at 6:00 p.m. The meeting was held at the Center Township Municipal Building, 419 Sunset Drive, Butler PA 16001.

ROLL CALL: Present were Chairman Schiebel; Vice Chairman Andrew Erie; Supervisors Ronald Flatt, Kenneth Frenchak, and Edward Latuska; and Township Secretary/Treasurer Anthony Amendolea. Cheryl Morris, Recording Secretary, was present.

PURPOSE: The purpose of this public hearing was to obtain public comment and testimony on Ordinance Nos. 2010-11-02, 2010-11-03, and 2010-11-04. These proposed amendments will amend the Center Township Codified Ordinances Chapter 14, Subdivision and Land Development, and Chapter 20, Zoning. The ordinances were submitted to the Butler County Planning Commission on October 6, 2010, by fax and regular mail, for their review. The notice of the public hearing was published in the Butler Eagle editions of October 24 and 31, 2010.

A summary of the proposed amendments are:

Chapter 14 – Subdivision and Land Development

- §14-202. Definitions
 - Add new definitions for “Manufactured Housing”, “Net Acreage”, “Net Density”, and “Recreational Vehicle Park”.
- §14-1101. Mobile Home Parks
 - Revise Subsection A., Mobile Home Lots
 - Delete Subsection A.10., Accessory Structures, in its entirety
 - Revise Subsection A.11., Decks, Ramps, and Porches
 - Delete Subsection A.12., Attached Rooms and Additions, in its entirety

Chapter 20 - Zoning

- §20-202. Definitions

Add new definition for “Changeable Copy Sign, Electronic”; “Dynamic Display”; “Mobile Home”; “Mobile Home Lot”; “Mobile Home Park”; “Net Acreage”; “Net Density”; “Recreational Vehicle Park”; “Sign, Video Display”; and “Snipe Sign”. In addition, revises definition for “Manufactured Housing”.

Revises Section 20-1408, Conditional Use Standards and Criteria, Subsection A.26, Manufactured Home Park:

- Revise Section 20-1605, Regulations, Subsection C, as follows:

§20-1605.C. Signs in the C-1, C-2 Commercial Districts, M-1, M-2 Industrial Districts, and Gateway Sign Overlay District

§20-1605.C.3.d. On-Premises Projecting Signs

§20-1605.C.3.e. On-Premises Temporary Construction Signs

§20-1605.C.3.f. On-Premise Canopy Signs

§20-1605.C.3.h. On-Premise Portable Signs

§20-1605.C.3.i. Dynamic Displays

§20-1605.C.4. Maximum Number and Placement of Signs

§20-1605.C.5. Illumination

§20-1605.C.6. Exemptions

- Revises Section 20-1606, Prohibited Signs
- Revises Section 20-1607, Permits, by adding a new Subsection C, Review and Approval Procedure
- Repeals all conflicting ordinances and sets forth an invalidity change
- Effective date of the Ordinances is five (5) days after enactment.
