CALL TO ORDER:

Chairman Ronald Flatt called the Regular Meeting, of the Center Township Board of Supervisors, to order at 6:30 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

PUBLIC TO BE HEARD:

The Board held an executive session on Tuesday, October 22, 2019 from 12:00 p.m. to 1:30 p.m. to discuss the Collective Bargaining Agreement with no action taken.

- A. Flatt read the following note from the Butler Area Public Library:
