#### **CALL TO ORDER:**

Chairman Ronald Flatt called the Regular Meeting, of the Center Township Board of Supervisors, to order at 6:30 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

### **PUBLIC TO BE HEARD:**

- A. Mr. Gary Wulff, 128 Whitmire Road: Mr. Wulff, Oneida Valley Fire Chief, asked for the necessary paper work for the Earned Income Tax Credit for firefighters.

### TREASURER'S REPORT:

- A. October 2018: Flatt motioned approving the October 2018 Treasurer's Report. Smallwood seconded. Motion carried.
- B. Warrant List 18-10-20: Flatt motioned approving Warrant List 18-10-20. Wulff seconded. Motion carried.
- C. Warrant List 18-11-21: Flatt motioned approving Warrant List 18-11-21. Wulff seconded. Motion carried.
- D. Authorize Ad for 2019 Proposed Budget: The Board of Supervisors reviewed the 2019 proposed budget at their workshop meetings held on Tuesday, October 9, 2018 and Tuesday, November 13, 2018. The 2019 budget reflects a balanced budget of \$1,921,900 in revenues and expenditures, with no tax increase. The Board will consider adopting the budget at their regular meeting scheduled for Wednesday, December 12, 2018 at 6:30 p.m. The budget will be available for public review at the Township office or the website. Flatt motioned authorizing placement of an ad for the 2019 Proposed Budget in the Butler Eagle edition on Sunday, November 25, 2018. Smallwood seconded. Motion carried.

**ZONING REPORT:** October 2018: Construction costs were \$711,705.00 fees collected were \$3,400.68. Wulff asked the status of 104 Swamp Run Road. Gauselmann, Building Code Official/Zoning Officer, stated the District Justice authorized an extension until June 1, 2018. Property is being cleaned but equipment broke down and employee quit. Elliott property is ninety (90) percent complete. Owner has eight (8) vehicles on the lot for repair.

#### **OLD BUSINESS:**

A. Ratify Duff Highlands Request No. 4 Release of Phase I Performance Bond: On October 31, 2018, Flatt and Wulff, respectively, based on Shoup's Engineering's recommendation, authorized the release of \$159,115.31 of the Phase I Performance Bond. Flatt motioned ratifying the release of \$159,115.31 from the Duffy Highlands Phase I Performance Bond. Sloan seconded. Motion carried.

#### **NEW BUSINESS:**

- A. Leicht & Associates Engagement Letter: Mr. William D. Leicht, Leicht and Associates, submitted an engagement letter to perform the 2018 Audit in the amount of \$20,000. Smallwood motioned authorizing Flatt to sign the Leicht and Associates engagement letter. Wulff seconded. Motion carried.
- B. Adopt CPA Appointment Resolution No. 2018-11-10: William D. Leicht and Associates submitted an engagement letter to conduct the 2018 Audit in the amount of \$20,000, which the Board agreed with. *Flatt motioned adopting the CPA Appointment Resolution No. 2018-11-10. Smallwood seconded. Motion carried.*
- C. Ratify Additional Debt Payment for Maintenance Facility: The required principal payment for 2018 is \$55,695.68 and interest is \$5,853.31 per loan agreement. Township Secretary/Treasurer Amendolea prepared a payment of \$201,548.99 which included \$55,695.68 with an additional \$140,000.00 on the principal and \$5,853.31 interest. Flatt motioned ratifying the additional principal payment of \$140,000.00 on October 24, 2018, check number 1016. Sloan seconded. Motion carried.

- D. Adopt 2015 International Codes Ordinance No. 2018-11-06: On October 1, 2018, the Commonwealth of Pennsylvania adopted the 2015 International Building Codes but only portions were adopted. Building Code Official/Zoning Officer Gauselmann stated 2009 codes are still in effect. Township Solicitor Gallagher stated that the statement "as amended from time to time" should suffice. Flatt motioned tabling the 2015 International Codes Ordinance No. 2018-11-06. Sloan seconded. Motion carried.
- E. Ratify Authorization and Payment for Brown Road (T-412) Repair: At the Board of Supervisors meeting held on Wednesday, September 12, 2018, the Board authorized Smallwood and Wulff, with assistance of Township Engineer Heath, to oversee the repair of Brown Road (T-412). The repair cost was \$5,000.00 for excavator and roller with operator which was performed by Smallwood Flatt motioned ratifying the (1) authorization for Smallwood to use an excavator and roller and (2) authorize payment of \$5,000.00 for repair of Brown Road (T-412). Sloan seconded. Smallwood abstained. Motion carried.
- F. Planning Commission Resignations/Appointments: On October 24, 2018, Neil Ashbaugh and Kasey McCollough resigned from the Planning Commission due to work related reasons.
  - 1. Planning Commission Appointment Schiebel Resolution No. 2018-11-11: Flatt motioned adopting Planning Commission Appointment Schiebel Resolution No. 2018-11-11 appointing Thomas G. Schiebel to complete Neil A. Ashbaugh's term from November 1, 2018 through December 31, 2019. Sloan seconded.

Wulff asked if the Board could fill the two (2) month vacancy, advertise for both vacancies one (1) year and four (4) year) and fill the positions in January 2019.

Flatt stated he wants to fill the positions to have a full board.
