# **ENGINEER'S REPORT:**

1. Brown Rd (T-412): There has been a crack noted in the road at this time. Gateway proposes to do test pits to visually observe what is going on at the shoulder of the road. Smallwood commented that we hired them to do the work, yet they are putting the responsibility back on the township. We paid them to do the job correctly, but it's not done correctly. Wulff stated that we got nothing out of the work that was done with the grant. Heath commented that Gateway would cover the observation and evaluation costs.

- 2. Water and Sewer Grant: Iroquois was submitted to the DEP and the bid package has been started. Glenwood Way can be put out to bid on condition that it is not awarded until the permit is issued, which will take 30-60 days.
- 3. ARLE Grant: All the applications were submitted, and the evaluations should start in June. Wulff commented that applications for grants should be submitted to the office sooner than the last day to submit.
- 4. Stoney Run Bridge: The work is completed and awaiting PennDot to do their inspection.
