

TOWNSHIP OF CENTER BUTLER COUNTY, PENNSYLVANIA ORDINANCE NO. 2024-07

AN ORDINANCE AMENDING CHAPTER 14, SUBDIVISION AND LAND DEVELOPMENT, AS AMENDED FROM TIME TO TIME, BY AMENDING ARTICLE XI, MOBILE HOME PARKS

WHEREAS, The Center Township Code Enforcement/Zoning Officer reviewed Chapter 14, Subdivision and Land Development; and

WHEREAS, the Center Township Code Enforcement/Zoning Officer recommended the following change; and

WHEREAS, the Center Township Planning Commission made a recommendation to approve at their meeting dated May 22, 2024; and

WHEREAS, the Butler County Planning Commission had no comments per review letter dated May 29, 2024; and

WHEREAS, the Center Township Board of Supervisors held a public hearing on July 8, 2024.

NOW, THEREFORE, be it ordained and enacted by the Center Township Board of Supervisors, and it is hereby ordained and enacted by the authority of the same as follows:

Section 1:	In Chapter 14, Subdivision and Land Development, Article XI,
	Mobile Home Parks, Section 14-1101, Mobile Home Parks, Paragraph
	A, Mobile Home Lots, Subparagraph 7 is amended to read as follows:

Each mobile home shall be located as referenced in the applicable Zoning District_ from any exterior lot line of the park or existing public road; not less than twenty (20) feet, from the curb or edge of street; not less than thirty (30) feet from any permanent structure or other mobile home not less than ten (10) feet from any accessory structure.

Section 2:	Repealer: All ordinances, code sections or parts thereof in conflict
	herewith are hereby repealed to the extent of such conflict.

Section 3:	Severability: Should any sentence, section, clause, part or
	provisions of this Ordinance amendment be declared by a court of
	competent jurisdiction to be invalid, the same shall not affect the
	validity of the Ordinance as a whole, or any part thereof, other than
	the part declared to be invalid.
