Center Township Board of Supervisors Regular Meeting Minutes August 14, 2024 6:30 p.m.

#### **CALL TO ORDER:**

Chairman Philip Wulff called the Regular Meeting, of the Center Township Board of Supervisors, to order at 6:30 p.m. The meeting was held at the Unionville Volunteer Fire Company Firehall, 102 Mahood Road, Butler PA 16001.

# **ROLL CALL:**

In addition to Chairman Wulff, present were Vice Chairman Robert Sloan; Supervisors Edward Latuska, Donald Pringle, and Alan Smallwood; Township Solicitor Michael Gallagher; Township Engineer Daivd Heath; and Secretary Kayla Mosey.

# **PUBLIC TO BE HEARD:**

1. Mr. Nathan Wulff, Assistant Fire Chief: Mr. Wulff presented the report for July 2024.

Mr. Wulff mentioned that running EMS calls is causing stress on the vehicles and they are running out of space on the trucks. The fire department is looking into purchasing a dedicated EMS vehicle, either a pickup or SUV. They have been looking into grants, but the township might have to apply on behalf of the fire department for the one. Mr. Wulff also gave an update on the SCBA purchase. They have been received and inventoried. There was a training night the previous evening with the members. A photo was taken with the Board of Supervisors and some members of the department.

2. Butch Sloan – 157 Thompson Town Rd: Mr. Sloan is offering \$35,000 toward the lien put on 298 W Brewster Rd. All the taxes have been paid on the property.

An executive session was called at 6:43pm for possible litigation. The meeting was reconvened at 6:49pm

The supervisors let Mr. Sloan know that his offer seems fair and that it will be taken into high consideration. The board would like to see that everything is paid up to date. The official decision will be made at the next meeting on September 11, 2024.

3. Scott Bishop – 135 N Benbrook Rd: Mr. Bishop is having a property dispute between him and his neighbors. There was a utility right of way agreement signed by two of the owners changing it from 30ft to 20ft. Mr. Bishop asked if all three should have had to sign. Also, the 15ft setback from the utility right of way to the house is not being met. Township Solicitor Gallagher suggested getting a private attorney.

U1 still has not turned in their Road Bond papers. They say they will fix the road damage on Blossom Rd.
