- B. Gary Rauschenberger 135 Windy Dr: Mr. Rauschenberger thanked the board for the job that they do and appreciates what they do but still feels the current health benefits are excessive compared to their wage.

Pringle commented that he was offended that Mr. Rauschenberger called the Township a swamp at the last meeting. The supervisors are doing their job. He stated that Smallwood volunteers his time at Onieda Valley Volunteer Fire Company as well as being a supervisor. That Latuska has been on the board for the last 30 years. He also mentioned there has been no tax increase. He stated that the residents are paying a penny a day for each supervisor and that they are doing the best that they can.

Sloan commented that he won't argue that the wage and benefits are disproportionate, however he wanted to provide a list of what the supervisors do monthly/yearly:

- a. They attend two board meetings a month.
- b. There is meeting prep.
- c. Special meetings are sometimes held.
- d. Some attend the Planning Commission Meetings.
- e. There are legal meetings.
- f. The supervisors review plans and ordinances.
- g. Attend to personnel issues.
- h. Union Negotiations.
- i. Sign off on payroll.
- j. Attend safety meetings/seminars.
- k. Take employees for drug testing.
- 1. Attend meetings with PennDOT for the annual paving contract.
- m. Apply for grants.
- n. Keep up with maintenance at the Township building.
- o. Sign checks and make bank deposits.
- p. Return phone calls from residents.

Rauschenberger responded back that he came to the conclusion after the agenda setting meeting that the board had an attitude of entitlement. He checked with other townships and found the following: that some pay for no insurance, some pay some, and some pay all. Mr. Rauschenberger stated that he could possibly see the supervisors having insurance for themselves as he understands they do a lot, however having insurance for spouses and family is too much.
