

TOWNSHIP OF CENTER BUTLER COUNTY, PENNSYLVANIA ORDINANCE NO. 2025-05-02

AN ORDINANCE AMENDING CHAPTER 15, SEWAGE DISPOSAL, AS AMENDED FROM TIME TO TIME, ARTICLE III, SANITARY SEWER LINE CONNECTIONS AND DELETE ARTICLE IV, SANITARY SEWER CERTIFICATION IN ITS ENTIRETY

WHEREAS, the Center Township Code Enforcement Officer reviewed the ordinances; and

WHEREAS, Pennsylvania American Water Company has discontinued the realty transfer inspection program as of October 29, 2024

WHEREAS, the Center Township Code Enforcement Officer made recommendations to the Center Township Board of Supervisors, and

WHEREAS, the Center Township Board of Supervisors agrees with the recommendations.

NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED by the Center Township Board of Supervisors, as follows:

Section 1:	In Chapter 15, Sewage Disposal, Article III, Sewer Line Connections,
	Section 15-309, Definitions, is amended to read as follows:

"Unacceptable Sanitary Sewage" and other terms used herein shall have the same meaning as when used in the rules and regulations of the Pennsylvania American Water Company and said rules and regulations of the Pennsylvania American Water Company are to be made applicable to all users of the aforementioned sanitary sewers.

Section 2:	In Chapter 15, Sewage Disposal, Article III, Sewer Line Connection	
	Section 15-311, Enforcement is amended to read as follows:	

The Pennsylvania American Water Company its officers, employees, successors and assigns, are hereby designated as the agent for this Article. The Company is empowered and authorized to take any and all lawful necessary actions in the name of the Township to enforce the obligations and prohibitions of said Article.
